Item 4. Resignation, Removal or Election of Registrant's Directors or Officers

At the regular meeting of the Board of Directors ("Board") held on 11 August 2022, at which meeting the directors who were present and still constituting a quorum, the Board elected the replacement Director Ms. Euvimil Nina R. Asuncion *vice* Asec. Paola Sherina A. Alvarez, who ceased to become a director due to her resignation from the Department of Finance. Director Asuncion shall serve the unexpired term of Asec. Alvarez, including assuming membership in the Finance Committee.

Item 9. Other Events

At the regular meeting of the Board of Directors held on 11 August 2022, at which meeting a quorum was present and acting throughout, the Board unanimously approved the following:

- (a) the financial and operating results as of 30 June 2022;
- (b) the supplemental capital expenditure (CAPEX) budget for 2022 in the estimated amount of Fourteen Billion One Hundred Ninety Seven Million One Hundred Ten Thousand Two Hundred Ninety Five and 43/100 Pesos (Php 14,197,110,295.43), to fund additional capital expenditure projects for the South Luzon Expressway;
- the appointment of Mr. Jacinto P. Dela Cruz, Jr. as the Internal Audit Group Head/Chief Audit Executive of the Company, as required by the SMC SLEX Inc. Corporate Governance Manual.
